| <p><b>Collection of your personal information</b></p>                    | <p>We will collect your personal information from you directly whenever it is reasonable and practical to do so. There are a number of ways we may collect your personal information, including when you:</p> <ul style="list-style-type: none"> <li>• Submit information through our website</li> <li>• Deal with us face-to-face, in writing (by letter, facsimile, or email), or by telephone</li> <li>• Participate in any of our events or promotions, or subscribe to any of our publications</li> <li>• Submit an application, quote, purchase order and/or service request to us</li> <li>• Visit our website (such as through the use of ‘cookies’ to record the way you use our website)</li> <li>• In the course of supplying products and services to you, or through our other dealings with you</li> </ul> <p>Where we outsource our functions to third party service providers, those providers may also collect personal information from you on our behalf.
