

The charts on this page reflect the relativity value of Australian wool in some user currencies. For countries such as China where there currency is fixed to the \$US at approximately 8.25 RMB (yuan) to US\$1 then variations in the A\$ vs US\$ can severly affect their buying power.



In general terms Australian exporters offer our wool around the world in what ever currency suits the importer.
